

**OPENING OF MAYOR APPOINTMENT SPECIAL MEETING**

Mayor Pro-Tempore Scott Yaeger opened the Remote/In Person Mayor Appointment Special Council meeting at 5:30pm. Council members present, in person were Scott Yaeger, Mark Weigand, Dede Boyer and Dennis Chamberlain. Council Members present remotely were Mike Schrag and Michelle Plumb. Council Member Debbie Chapman attended but not as a council member due to the Mayor appointment agenda items. Staff members in attendance were Clerk-Treasurer Julie Flyckt, Deputy Clerk Treasurer II Michelle Asmussen, Deputy Clerk Treasurer I Kim Smith, City Attorney John Kragt, and City Police Chief David McCormick. Also present in person was Katie Teachout from the Adams County Journal, and Linda Kadlec.

**ACCEPTANCE OF THE CONSENT AGENDA**

Mayor Pro-Tempore Scott Yaeger asked if there were any changes to the consent agenda. Council Member Mark Weigand made a motion to accept the consent agenda. Council Member Dennis Chamberlain seconded the motion. Motion passed 6-0.

**PUBLIC COMMENTS**

- A. The mayor appointment will need to be done through a motion, second and a majority vote by council. Council Members Mike Schrag, Dede Boyer, Michelle Plumb, and Scott Yaeger opposed. Motion failed 2-4. Council Member Dennis Chamberlain made a motion to appoint Linda Kadlec as mayor from today until November 2021. Council Member Mark Weigand opposed. Motion passed 5-1.
- B. Oath of Office Administered-** Clerk-Treasurer Julie Flyckt administered the oath of office to the new mayor Linda Kadlec. Linda signed the official oath of office document which will be submitted to the auditor's office.
